



**SUBJECT: EASO/2015/391 – Renovation of EASO building(s) restrooms
EX ANTE PUBLICITY NOTICE**

I. Background

The European Asylum Support Office (EASO) wishes to renovate its restrooms, comprising of tiling to the floors and walls of all bathrooms and shower rooms, changing of bathroom fittings as necessary, such as sinks and toilet bowls with the possibility of installing bidets. The cisterns and taps will also need to be changed. The partitioning in the bathrooms will also need to be re-designed. Installation will also form part of the works. Ancillary services such as plumbing and electricity will also be included in the contract.

II. Description of the supplies and services

The indicative, although not exhaustive, list of supplies and services is as follows:

- Partitions
- Wall and floor tiles
- Shower tray
- Shower glass
- Toilet bowls
- Toilet seat and cover
- Bidets
- Taps
- Sinks
- Flushing cisterns
- Mechanism for cisterns

- Bathroom heaters

- Toilet roll holders
- Mirrors
- Lighting
- Aids for disabled bathrooms
- Plumbing works
- Electrical works
- All necessary installation of the above, pipework, electrical cables and necessary ancillary equipment

III. Description of the contract

EASO envisage awarding a framework supply contract. The duration of the contract shall be 2 years. The estimated maximum amount for this contract is € 60.000.

IV. Description of the procurement procedure

This ex-ante publicity is the first stage of a negotiated procurement procedure with at least 3 economic operators through which EASO may award the above-mentioned framework contractⁱ.
