I. Description of the supplies and services

The European Asylum Support Office (EASO) is planning to purchase the following items/services that shall be provided in Cyprus:

LOT 1: health related products. A non-exhaustive list of the products EASO intends to procure (supply and delivery to multiple locations in Cyprus) is presented below:

- Disposable light medical gloves
- Disposable type IIR surgical facemask
- Disposable medium efficiency respiratory facemask
- Hand sanitizer
- Insect repellent spray
- Disposable single-use gown for first assessment
- Wet disinfectant cloth for surface cleaning
- Spray for disinfection of surfaces
- Sunscreen

LOT 2 safety related products and supporting services. A non-exhaustive list of the products EASO intends to supply and to be delivered/assembled to the requested locations is presented below:

- Fire Extinguisher – Type ABC, 6kg
- Fire Extinguisher – Type CO2, 5kg
- Fire Extinguisher – Type Foam, 6 liters
- Boxes for housing sets of 3 fire extinguishers
- Stand-alone fire detection system
- Whistles
- Led headlamps
- Fire blankets
- Fire signs and exit signposts
- First aid medical kits
- Fully Automatic AEDs.

Apart from above listed products the selected contractor shall provide annual inspection and refilling of all 3 types of fire extinguishers

II. Description of the contract

EASO envisages awarding a single Framework contract with the economic operator fulfilling the exclusion, selection and award criteria of this procurement procedure. The duration of the contract will be for a period of twelve months and may be automatically renewed three times for twelve months each (maximum duration **48 months**). The estimated maximum amount for these contracts is:

- Lot 1: 21,000.00 EUR;

- Lot 2: 29,000.00 EUR.

Both amounts include a 10% contingencies.

III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 3 economic operators through which EASO may award the above-mentioned contract.¹

This ex-ante publicity has an indicative value and is in no way binding on EASO. EASO may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority to take part in the procedure concerned can submit a tender.

Economic operators interested in being invited to participate in this procedure may express their interest by writing to CONTRACTS@easo.europa.eu by the **11/12/2019** and indicating the **procedure Lot(s) they would like to be invited to participate.**²
