## **EASO/2021/854 – Negotiated Procedure for the Procurement of photographic and video equipment for EASO**

### **EX ANTE PUBLICITY**

#### **I. Description of the supplies**

The European Asylum Support Office (EASO) is planning to purchase photographic and video equipment.

- A shoulder mount rig;

- Live streaming equipment;
- Camera stabilisers;
- Shelving system;
- Cabinets;
- Backdrops and backdrop mounting systems;
- Technical Assistance - on site services (travel and daily allowances covered by EASO).

## II. Description of the contract

EASO envisages awarding a single framework contract. The maximum estimated duration of the contract will be 48 months. The estimated total value for the whole framework contract duration is € 138,500.

### III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators through which EASO may award the above-mentioned contract.<sup>1</sup>

This ex-ante publicity has an indicative value and is in no way binding on EASO. EASO may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority to take part in the procedure concerned can submit a tender.
