EASO/2021/864 - Framework Contract Packaging, Removal and Storage Services for EASO

EX ANTE PUBLICITY

I. Description of the services

The European Asylum Support Office (EASO) is planning to purchase packaging, removal and storage services for its headquaters in Valletta (Malta) and for any other location where EASO has Operations.

More in detail, the requested services will include:

- Pack, move and unpack various kitchenette equipment such as fridges and microwaves;
- Move furniture, including dismantling and assembling back when necessary;
- Move plants, safes and other office supplies;
- Provide all necessary equipment to ensure the protection of items during removal (packing and wrapping material, tapes, pallets, crates, boxes and other accessories);
- Provide removal insurance;
- Provide delivery trucks, lifters, trolleys, hand tools for dismantling and reassembly of items;
- Provide move management services, for the coordination between EASO and removal team;
- Provide a furniture lifter, able to lift up to 6 floor high;
- Provide storage services for short term (up to 7 days), long term (up to 1 year) and international storage including CCTV-monitoring 24/7;
- Provide the needed transportation services for removal.

II. Description of the contract

EASO envisages awarding a framework contract. The maximum estimated duration of the contract will be 48 months. The estimated total value for the whole framework contract duration is € 100,000.00.

III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators trough which EASO may award the above-mentioned contract.¹

This ex-ante publicity has an indicative value and is in no way binding on EASO. EASO may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.
