# EASO/2021/900 – Framework Contract for the Provision of Assessment centre services for candidates within EASO selection procedures for middle managers /managerial positions

#### **EX ANTE PUBLICITY**

### I. Description of the services

The European Asylum Support Office (EASO) is planning to purchase assessment centre services for the assessment of candidates short-listed for managerial positions. The purpose is to provide technical assistance, support and the know-how to EASO to select and recruit middle managers by developing, organising and running assessment centres.

The requested services will include:

- developing, organising and running of assessment center(s) where the candidates will take a series of different tests/assessment tools to evaluate their competences, skills and abilities as managers/middle managers in relation to the duties of the position for which they applied as well as the conditions and requirements established for the relevant recruitment procedure;
- production of individual detailed assessment reports for each candidate.

## II. Description of the contract

EASO envisages awarding a Framework contract. The maximum estimated duration of the contract will be 48 months. The estimated total value for the whole framework contract duration is € 138,000.00.

#### III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators trough which EASO may award the above-mentioned contract.<sup>1</sup>

This ex-ante publicity has an indicative value and is in no way binding on EASO. EASO may decide not to launch the procurement procedure without candidates being entitled to claim any compensation.

Only candidates invited by the contracting authority (EASO) to take part in the procedure concerned can submit a tender.
