I. Description of the services:

The European Asylum Support Office (EASO) is planning to renew and upgrade its Journal collection on asylum issues, to support EASO experts in their research and to keep them abreast of developments in the field of asylum, EU law and training. The purchase of subscriptions will provide EASO staff with the means to keep themselves informed of developments in the asylum field.

II. Description of the contract

EASO envisages awarding a service framework contract. The duration of the contract will be maximum 4 years. The estimated maximum amount for this contract is € 75,000.

III. Description of the procurement procedure

This ex-ante publicity is the first stage of the negotiated procurement procedure with at least 5 economic operators through which EASO may award the above-mentioned contract.¹

This publication has an indicative value and constitutes no obligation to award a contract for EASO.

Only the tenderers invited by the contracting authority to participate to this procedure will be admissible.
